RESOLUTION NO. 112-2018

RESOLUTION APPROVING THE GENERAL FUND SUPPLEMENTAL BUDGET NO.001 OF BARANGAY SABANG, THIS MUNICIPALITY AS EMBODIED IN THEIR APPROPRIATION BILL NO.001 SERIES OF CALENDAR YEAR 2018.

WHEREAS, a preliminary review was made on the Barangay Supplemental Budget No.001 of Barangay Sabang, Pinamalayan, Oriental Mindoro, appropriating the total amount of Php 833,186.52 representing the Un-appropriated Balance of 2017 and the increase in the barangay's share in Internal Revenue Allotment for the period of September to December 2017, and approved under Appropriation Ordinance No.001 series of CY 2018.

WHEREAS, it appears that this budget has complied the general limitations and budgetary requirements set forth in RA 7160 and the existing budgeting rules and regulations, and maybe declared operative and in effect as of the date fixed in the Appropriation Ordinance subject to the posting requirements under Section 59 of RA 7160 and to the following conditions, to wit:

- 1. The granting and disbursement of appropriations provided under MOOE and Property, Plant and Equipment shall be in accordance with the provision of Government Procurement Reform Act (RA 9184) and its Implementing rules and Regulations (IRR);
- 2. That 20% Development Fund shall be utilized with the allowed capital expenditures in accordance with DILG-DBM Joint Memorandum Circular No. 2017 01 dated February 22, 2017;
- 3. That the allocation of 10% SK Fund shall be used solely for Youth Development Programs or Projects under the new set of SK officials who have been duly elected and qualified and access to SK Funds shall be in accordance with RA 10632 and its Implementing Rules and Regulations (IRR);
- 4. The appropriation for Barangay Disaster Risk Reduction and Management (BDRRM) Fund shall be in accordance with the approved BDRRMC Plan of the Barangay per Republic Act 10121 and in accordance with Item 5.1.3 of COA Circular No. 2012 002 dated September 12, 2012, which states:
 - "5.1.3. The release and use of the LDRRMF shall be supported by the following: 5.1.3.1. Local Sanggunian Resolution and the declaration of state of calamity for the Quick Response Fund.
 - 5.1.3.2. LDRRMF Investment Plan for projects and activities listed in the approved plan as incorporated in the local development plan and annual work and financial plan."
 - 5. That the account titles and codes used shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015 entitled "Prescribing Revised Chart of Accounts of Local Government Units";
 - 6. The Punong Barangay is advised to go through the Standard Operating Procedures in the Planning and Budgeting process and submit the General Fund Barangay Annual Budget on time in compliance with Section 333 of Republic Act 7160 (a) "within ten (10) days from its approval, copies of the Barangay Ordinance authorizing the annual appropriations shall be furnished the Sangguniang Panglungsod or the Sangguniang Bayan, as the case maybe, through the city or municipal budget officer" (underscoring ours) and;
